2.2.3 Use of Force

The department has had 33 incidents of use of force that occurred since the most recent On-site Assessment, August 2002. Out of those reported, ten officers indicated the use of O.C. Spray, fifteen reported the used of Physical Empty Hand, six officers used the Taser and three incidents showing the use of the pistol during felony arrests. There are no indications of any officer using a considerable amount of use of force. Only two officers showed using force in three or four incidents during the reporting period. Only one officer used the Taser in two separate incidents. Five of the thirty-three reported Use of Force incidents involved multiple officers of 2 or more.
