#### August 13, 2024

A called meeting of the Public Building Authority of the City of Sevierville, Tennessee, was held at Sevierville Chamber of Commerce 110 Gary Wade Boulevard, Sevierville, Tennessee, on August 13, 2024, at 2:00 PM.

Chairman Temple chaired the meeting with Shelly Franklin as secretary of the meeting. A motion was made by Director Murrell and seconded by Vice Chairman Sutton to approve the April 16, 2024, minutes and to dispense with the reading. Motion carried.

#### **PUBLIC FORUM**

Chairman Temple opened the public forum. There being no comments, the public forum was closed.

#### **REPORTS**

Monday August 19, 2024 at 4:45 PM is the ribbon cutting for the Community Center and Police Department renovations.

#### **NEW BUSINESS**

Chairman Temple recognized Bob Moncrief, who requested approval of an operating contract respecting the construction of the Kodak Center Project with the City of Sevierville. This project includes construction of Fire Station 4, meeting space and offices for general use by the Police and other City departments, a pre-engineered metal storage building for Public Works and other departments to store equipment, a fuel farm, salt storage bin, and other material storage bins. The total budget is \$10,000,000.00 which includes engineering, architecture and construction. A motion was made by Director McCroskey and seconded by Director Ratcliff to approve the operating contract as presented. Motion carried.

Chairman Temple recognized Bob Moncrief, who requested approval to enter into a Construction Manager at Risk Contract with Vannoy Construction for the Kodak Center Project. Moncrief stated that after reviewing all information submitted and checking references, Vannoy Construction has the best qualifications for this project. A motion was made by Vice-Chairman Sutton and seconded by Director Murrell to approve entering into agreement with final review and approval by PBA Attorney and City Risk Manager. Motion carried.

Chairman Temple recognized Bob Moncrief, who requested approval to pave and stripe the impound lot adjacent to the new police department equipment building. Moncrief stated a not-to-exceed cost of \$35,000.00. A motion was made by Director Tarwater and seconded by Director Ratcliff to change the not-to-exceed cost to \$40,000 based on a recommendation by Lynn McClurg, CFO. Motion carried. A motion was made by Director Murrell and seconded by Vice-Chairman Sutton to approve the request for paving and striping the lot with change of amount to \$40,000.00. Motion carried.

# RESOLUTION DIRECTING THAT REVENUE AND RECEIPTS OF THE PUBLIC BUILDING AUTHORITY OF THE CITY OF SEVIERVILLE BE REMITTED TO THE CITY OF SEVIERVILLE UNLESS OTHERWISE DESIGNATED BY THE AUTHORITY

**WHEREAS**, the incorporation of the Board was authorized by the City of Sevierville Board of Mayor and Aldermen on June 19, 2003; and

**WHEREAS**, the board is a nonprofit corporation, a public benefit corporation and public instrumentality of the City of Sevierville, and

**WHEREAS**, the Board may receive revenue in the form of payments for services, payments from the sale or lease of property or other miscellaneous payments,

## NOW, THEREFORE, BE IT RESOLVED BY THE PUBLIC BUILDING AUTHORITY OF CITY OF SEVIERVILLE, TENNESSEE, THAT:

**Section 1.** Any revenue, payments, monies or other assets received by the Public Building Authority shall be immediately remitted to the City of Sevierville unless otherwise designated by the Authority.
